The City of Seat Pleasant wishes to remind some and inform others of the available electric vehicle charging stations located in the Seat Pleasant City Hall parking lot, 6301 Addison Rd.

In 2019, Pepco-Exelon launched its EVsmart Program in Prince George's and Montgomery Counties. Their goal was to place 250 charging stations throughout these counties in government-owned public areas.

Each station has two charging ports, two dedicated parking spaces, and are available for public use 24 hours a day.
