- Fill remaining vacant positions (SPPD)
- Continue Workforce Development (SPPD and NCC)

Objective Outcomes To-Date:

SPPD Administrative Outcomes

SPPD was awarded a grant from the Governor's Office of Crime Control and Prevention. Funding allocations can be found below:

- \$1,000 Bilingual bonus (2 @ \$500 each)
- \$3,000 Veteran bonus (3 @ \$1,000 each)
- \$2,500 Boot allowance (25 @ 100 each)
- \$7,500 Referral bonus (15 @ \$500 each)
- \$11,520 Uniform Maintenance
- SPPD was also awarded a Local Government Insurance Trust Grant for \$5,000.

The Department is working rigorously to fill all vacant positions. We are eager to sponsor new recruits from our community and are engaging in city-wide recruiting efforts. Please see the recruitment details below:

- Since July 2021 we have received 54 applicants for the position of Police Officer
- Currently have 10 in the background process
- 11 are scheduled to complete the upcoming Physical Agility Test
- 5 female applicants with 1 currently in the background process
- 3 new hires for police officer (1 recruit, 2 experienced officers)
- 1 academy graduate (Officer A. Johnson)

Training

SPPD continued its commitment to workforce development. Please see the list of training below.

- Command staff member graduate of Session 78 PERF Senior Management Institute for Police.
- 4 Seat Pleasant Officer's attended and completed a National Tactical Officer (SWAT) training. This school provided advance training for officers to apply tactical operation within policing incidents in our community.
- 3 Officers completed a METERS trainer course, allowing officers to train other officers in the use of the METERS platform.
- 1 Officer attended and completed Advanced Roadside Impaired Driver Enforcement (ARIDE) program
- 1 Officer has completed the Drug Abuse Resistance Education (DARE) program. This program will allow the department to teach DARE curriculum in partnership with out elementary school.
- 1 Officer has completed Crime Scene and Accident Photography school.
- 1 Officer has completed TASER instructor recertification.
- 2 Officers completed MML-Police Executive Association training
- 2 Officers completed LEEDS training
- 1 Officer completed COPS Unit training with McGruff the Crime Dog
- 1 officer completed Understanding Development & Intellectual Disabilities training
- 1 Officer completed Tactical Medical for First Responders Training
- 1 Officer completed SFST Refresher Training
- All members of the administrative staff are now METERS certified.
- 2 Officers completed ICAT (Integrated Communications and Tactics) Training, which is a course designed to help officers use enhanced verbal skills to deescalate interactions with subjects in mental crisis.
- The entire police department also attended a course facilitated by the Powers Group, titled "The Principled Leader" that focused on leadership and ethics. The class delved into appropriate vs. inappropriate interactions with the public, officer accountability, and professional standards. This is the first class in a line of training designed to reinforce professional standards and broaden the department's skillset concerning public engagement

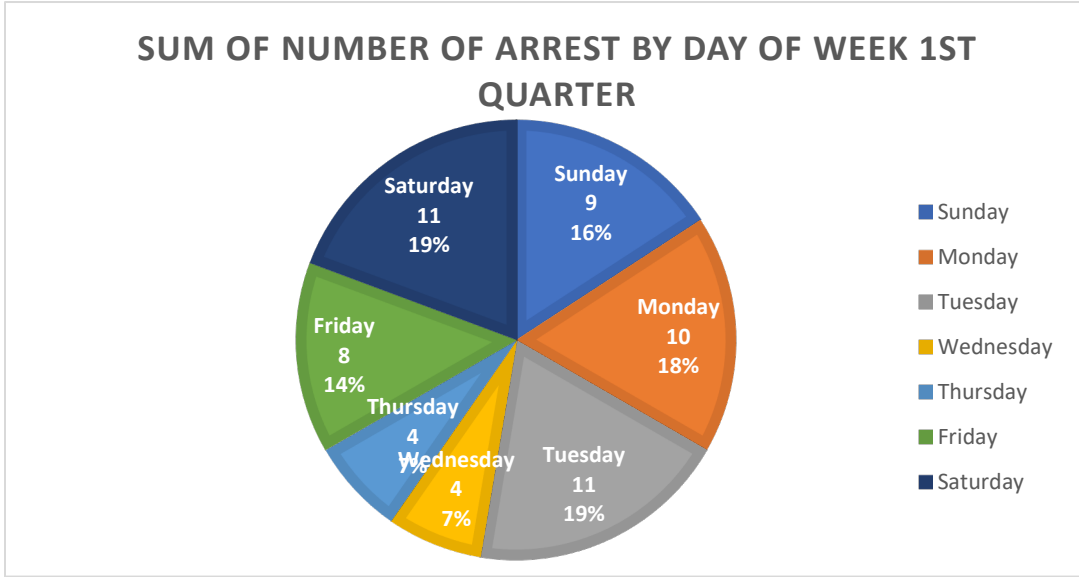
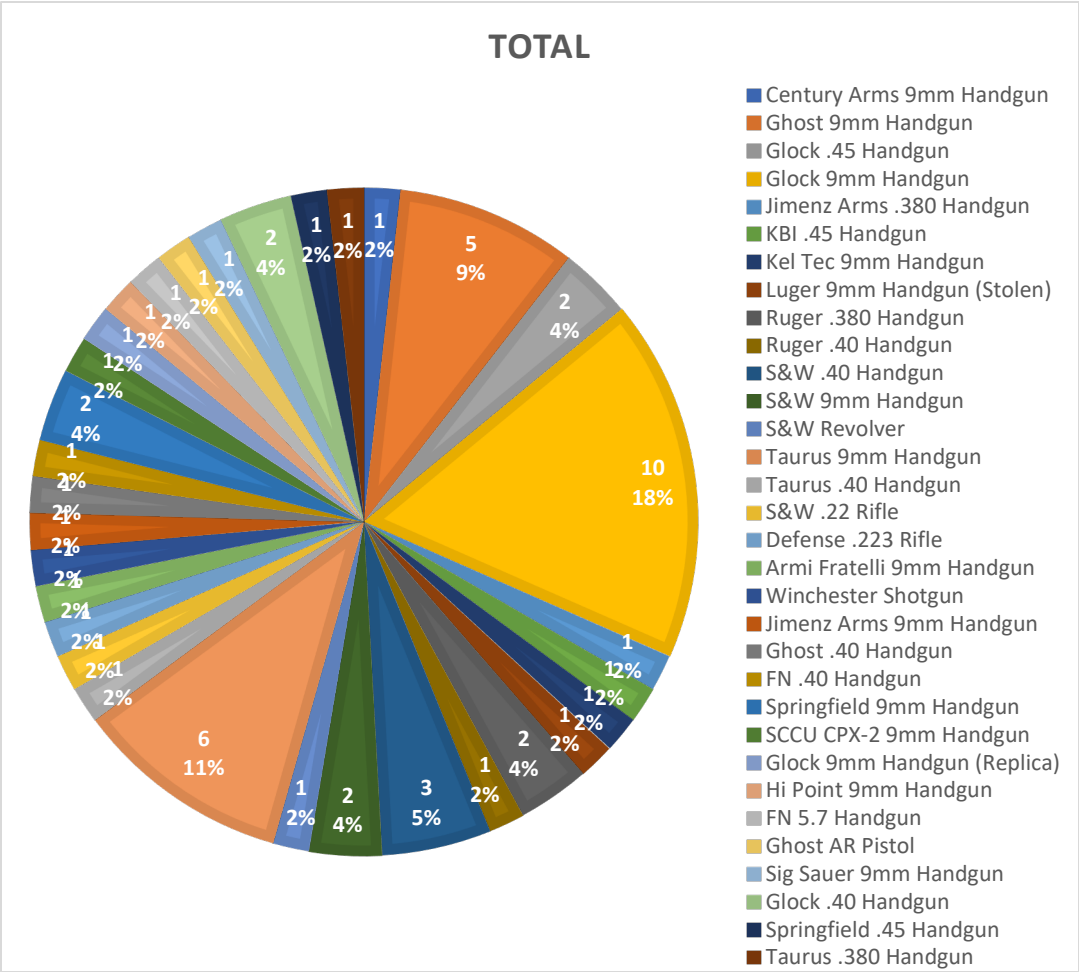
Through targeted patrol efforts, we have seen a pronounced decrease in Part 1 offenses.

Gun Violence Reduction Program

The Seat Pleasant has been diligently working to reduce gun violence and has recovered close to 60 handguns since January 2021. During this quarter **22 firearms** were recovered from our streets, compared to last quarter **13 firearms** were recovered which is a **40% increase on firearms recovered**.
