**AN EMERGENCY ORDINANCE concerning**

**CABLE TELEVISION FRANCHISE APPLICATION FEE**

**FOR** the purpose of establishing a fee for the filing of an application for a cable television franchise with the City of Seat Pleasant; providing that this Ordinance shall be an Emergency Ordinance effective from the date of its passage; and all matters generally related to applications for cable television franchises in the City of Seat Pleasant.

**SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL** that an emergency exists that affects life, health, property or the public peace requiring immediate action. The emergency is that the City must expeditiously determine the amount of a cable television franchise application fee in order to accept an application fee and franchise application that has been filed by Verizon.


**SECTION 2. BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL** that, pursuant to Section 71-19.C. of the Seat Pleasant City Code any application for a CATV franchise shall be accompanied by a non-refundable application fee in the amount of \$5,000 to be used by the City to offset expenses incurred in the application evaluation and franchising process.

**SECTION 3. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL** that, having been approved by the affirmative vote of at least two-thirds (2/3rds) of the entire City Council, the City Clerk shall certify to the adoption of this Emergency Ordinance, and cause the same to be published as required by law; and that this Emergency Ordinance shall become effective twenty (20) days following approval by the Mayor or passage by the Council after the veto by the Mayor.


