SECTION 1. BE IT ORDAINED AND ENACTED by the Mayor and City Council of Seat Pleasant, Maryland that the sums and amounts appropriated for the Fiscal Year beginning July 1, 2006 and ending June 30, 2007.

SECTION 2. AND BE IT FURTHER ORDAINED AND ENACTED that the following sums and amounts are hereby appropriated for the Fiscal Year beginning July 1, 2006 and ending June 30, 2007 to defray expenses and operations cost for the City of Seat Pleasant.

SECTION 3. AND BE IT FURTHER ORDAINED AND ENACTED that the Real Property Tax for the Fiscal Year beginning July 1, 2006 and ending June 30, 2007, shall be at the rate of fifty-eight cent (.58) per hundred dollars (\$100.00) of assessed real property value.

SECTION 4. AND BE IT FURTHER ORDAINED AND ENACTED that the Personal Property Tax for the Fiscal Year Beginning July 1, 2006 and ending June 30, 2007, shall be at the rate of eleven dollars (\$11.00) per one hundred dollars (\$100.00) of assessed property value.

SECTION 5. AND BE IT FURTHER ORDAINED AND ENACTED that this ordinance is advertised twice in a newspaper of general circulation in the City of Seat Pleasant, Maryland within twenty days of enactment.

SECTION 6. AND BE IT FURTHER ORDAINED THAT this ordinance is hereby adopted for the day of May 30, 2006 and shall be effective after publication and posting as required by the City Charter.
