AN ORDINANCE concerning

**AMENDMENT OF THE

SECTION I. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2006-2007 Budget of the City of Seat Pleasant shall be amended as follows:





AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that, having been approved by the affirmative vote of at least two-thirds (2/3rds) of the entire City Council, the City Clerk shall certify to the adoption of this Ordinance, and cause the same to be published as required by law; and that this Ordinance shall become effective twenty (20) days following approval by the Mayor or passage by the Council after the veto by the Mayor.


