**DECLARATION AND CONSENT TO  
A RECESS OF THE COUNCIL OF THE CITY OF SEAT PLEASANT**

**RESOLVED**, that when the Council of the City of Seat Pleasant (the “City Council”) adjourns on Friday, July 29, 2022, it shall be in recess until Wednesday, August 31, 2022.

The foregoing recess is in accordance with Section 3.1 of the Council’s Rules of Procedure, adopted pursuant to the authority of Section C-307 of the Charter of the City of Seat Pleasant (the “Charter”).

Notwithstanding the recess effective upon the City Council’s adjournment on July 29, 2022, the City Council may reconvene in a Special Session at any time prior to August 31, 2022, at the request of the mayor, or four (4) or more Councilmember's, pursuant to and in accordance with Section C-304 of the Charter and Section 3.5 of the Council’s Rules of Procedure.

**AND BE IT FURTHER ENACTED AND RESOLVED** that this Resolution be and is hereby enacted this 11th day of July 2022 to take effect immediately.
