AN ORDINANCE concerning

SEAT PLEASANT FY 2008 BUDGET AMENDMENT

FOR the purpose of amending the City's FY 2007-2008 budget to require that appropriations made in the City's approved budget ordinance be expended for certain specific purposes.


EXPLANATORY STATEMENT: On June 4, 2007 the Seat Pleasant City Council enacted Ordinance O-07-05 to adopt a budget for the City for the fiscal year beginning July 1, 2007 and ending June 30, 2008. Ordinance O-07-05 appropriated funds for expenditures in broad, general categories of expenditures although, during its deliberations, the City Council was presented with and reviewed a "budget book" that contained detailed line items and categories of expenditures for the different agencies, departments and functions of the City government. The City Council desires by this Ordinance to ensure that funds appropriated by Ordinance O-07-05 are expended only for such purposes and in such amounts as were considered and approved by the Council during its budget deliberations, even though the "budget book" and the details of such proposed expenditures were not expressly enacted as part of Ordinance O-07-05.

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that from and after the effective date of this Ordinance funds appropriated to the general categories of expenditures by and as reflected in Ordinance O-07-05 shall be expended only for such purposes, and up to such amounts for each such purpose, as set forth in the document entitled "APPROVED BUDGET FY 2008" attached to this Ordinance and incorporated herein by reference.

SECTION 2. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the City Clerk shall certify to the adoption of this ordinance, and cause the same to be published as required by law; and that this Ordinance shall become effective twenty (20) days following approval by the Mayor or unless subsequently passed by a favorable vote from


five members of the whole Council after the veto by the Mayor.




