**AMENDMENT OF THE
FISCAL YEAR 2022-2023 BUDGET

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2022-2023 Budget of the City of Seat Pleasant, as enacted by Ordinance O-22-10, adopted on July 7, 2022, shall be amended to include the Government Office of Crime Control and Prevention Grant for Recruitment in the Seat Pleasant Police Department.
