**AN ORDINANCE concerning**

**AMENDMENT OF THE  
FISCAL YEAR 2009-2010 BUDGET  
FOR THE CITY OF SEAT PLEASANT, MARYLAND**

**SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL** that the 2009-2010 Budget of the City of Seat Pleasant, as enacted by Ordinance O-09-10, adopted on June 8, 2009, shall be amended by deleting in its entirety Section 6 of that Ordinance, which provide as follows:

**~~((SECTION 6. AND BE IT FURTHER ORDAINED AND ENACTED that the cost of living increases will only be given after there are satisfactory evaluations of each employee entitled to these increases. ))~~**

**SECTION 2. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2009-2010 Budget of the City of Seat Pleasant, as enacted Ordinance O-09-10, adopted on June 8, 2009, shall be amended by repealing and reenacting with amendments, Section 7 of that Ordinance, to read as follows:**

**SECTION 7. AND BE IT FURTHER ORDAINED AND ENACTED that the cost of salary upgrades reflected in the ((Police and Public Works Department)) Approved Budget 2010 ((will)) MAY only be given after there are satisfactory performance evaluations of each employee entitled to these increases.**


**SECTION 3. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL** that, having been approved by the affirmative vote of at least two-thirds

(2/3rds) of the entire City Council, that the City Clerk shall certify to the adoption of this Ordinance, and cause the same to be published as required by law; and that this Ordinance shall become effective twenty (20) days following approval by the Mayor or passage by the Council after the veto by the Mayor.


