AN EMERGENCY ORDINANCE concerning

**AMENDMENT OF THE
FISCAL YEAR 2010-2011 BUDGET
FOR THE CITY OF SEAT PLEASANT, MARYLAND**

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2010-2011 Budget of the City of Seat Pleasant, as enacted by Ordinance O-10-10, adopted on June 14, 2010, shall be amended as follows:


SECTION 2. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that an emergency exists that affects life, health, property or the public peace requiring immediate action. The emergency is that delays that would be occasioned by proceeding with this Ordinance as a regular ordinance effective in twenty (20) days after approval by the Mayor or approval of the City Council over the

veto of the Mayor due to the constant flow of water, which makes the street conditions dangerous with the current temperatures.


SECTION 3. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that, having been approved by the affirmative vote of at least two-thirds (2/3rds) of the entire City Council, the City Clerk shall certify to the adoption of this Ordinance, and cause the same to be published as required by law; and that this Ordinance shall become effective immediately following approval by the Mayor or passage by the Council after the veto by the Mayor.




