AN ORDINANCE concerning

STREET VENDING

FOR the purpose of providing a fee for the issuance of annual and temporary street vending licenses; altering penalties for violation of street vending regulations and providing for enforcement of such regulations; and generally relating to regulation of street vending in The City of Seat Pleasant.

BY repealing and reenacting, with amendments
 Chapter 141 Street Vending
 Sections 141-9 and 141-16
 Code of the City of Seat Pleasant (1994 Edition, as amended)

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that Sections 141-9 and 141-16, Code of the City of Seat Pleasant (1994 Edition, as amended), Chapter 141, Street Vending, are repealed and reenacted, with amendments, to read as follows:

Chapter 141

STREET VENDORS

§ 141-9. Fees.

Each vendor granted ((a)) AN ANNUAL license under this chapter shall pay an annual license fee ((as established by the City Council)) IN THE AMOUNT OF \$100. ((Vendors)) EACH VENDOR granted A temporary vending ((licenses)) LICENSE for A special ((events)) EVENT shall pay a TEMPORARY LICENSE fee ((as established by the City Council)) IN THE AMOUNT OF \$25.


§ 141-16. Violations and penalties.

A VIOLATION OF THIS CHAPTER IS A MUNICIPAL INFRACTION. Any person who violates any provision of this chapter shall be punished by a fine ((not to exceed \$1,000 or by imprisonment not to exceed six months, or by both fine and imprisonment)) IN THE AMOUNT OF \$200 FOR EACH OFFENSE. A PERSON COMMITS A SEPARATE OFFENSE EACH DAY THAT THE PERSON VIOLATES A PROVISION OF THIS CHAPTER. CITY POLICE OFFICERS AND CITY CODE ENFORCEMENT OFFICERS MAY ENFORCE THE PROVISIONS OF THIS CHAPTER AND ISSUE CITATIONS FOR VIOLATIONS.


SECTION 2. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the City Clerk shall certify to the adoption of this Ordinance, and cause the same to be published as required by law, and that this Ordinance shall become effective twenty (20) days following approval by the Mayor or passage by the council after veto by the Mayor.


