AMENDMENT OF THE FISCAL YEAR 2024-2025 BUDGET FOR THE CITY OF SEAT PLEASANT, MARYLAND

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2024-2025 Budget of the City of Seat Pleasant, as enacted by Ordinance O-24-13, adopted on May 13, 2024, shall be amended to include an increase for Contractual Services, Chief Financial Officer salary, bonus and new accounting software.
