AN EMERGENCY ORDINANCE concerning

**AMENDMENT OF THE
FISCAL YEAR 2013-2014 BUDGET
FOR THE CITY OF SEAT PLEASANT, MARYLAND**

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2013-2014 Budget of the City of Seat Pleasant, as enacted by Ordinance O-12-18, adopted on May 28, 2013, shall be amended for the purchase of a Modular Building for the Seat Pleasant Police Department, as follows:



SECTION 2. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY
COUNCIL that an emergency exists that affects life, health, property or the public peace requiring immediate action. The emergency is that delays that would be occasioned by proceeding with this Ordinance as a regular ordinance effective in twenty (20) days after approval by the Mayor or approval of the City Council over the veto of the Mayor would prevent the City of Seat Pleasant from acquiring in a timely manner a Modular Building for Seat Pleasant Police Department to have a permanent facility in Seat Pleasant.
