AN ORDINANCE concerning

**AMENDMENT OF THE
FISCAL YEAR 2012-2013 BUDGET
FOR THE CITY OF SEAT PLEASANT, MARYLAND**

FOR the purpose of amending the 2012-2013 Budget of the City of Seat Pleasant, as enacted by Ordinance O-12-18, adopted on May 30, 2012 to account for the purchase of iPad tablets for the City Council, City Administrator, and City Clerk from funds allocated to the City Administration's budget.

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2012-2013 Budget of the City of Seat Pleasant, as enacted by Ordinance O-12-18, adopted on May 30, 2012, shall be amended as follows:
