**AN ORDINANCE concerning**

**AMENDMENT OF THE

**SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL** that the 2013-2014 Budget of the City of Seat Pleasant, as enacted by Ordinance O-12-18, adopted on May 28, 2013, shall be amended for the purchase of Security Camera's for Public Works and Vest for the Police Department as follows:






