AMENDMENT OF THE FISCAL YEAR 2024-2025 BUDGET FOR THE CITY OF SEAT PLEASANT, MARYLAND

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2024-2025 Budget of the City of Seat Pleasant, as enacted by Ordinance O-24-13, adopted on May 13, 2024, shall be amended to include the Government Office of Crime Control and Prevention Grants for Gun Violence, Body Armor and Warrants and Absconding for Seat Pleasant Police Department.




