A RESOLUTION concerning

**REVISING THE APPOINTMENT OF THE CITY OF SEAT PLEASANT SMART CITY
ADVISORY BOARD**

WHEREAS, The City of Seat Pleasant (the “City”) has designated itself as a Smart City that uses technology as a tool that revitalizes the community, creates a safer urban environment, improves education, effects workforce development, enhances the quality of life for citizens and makes significant contribution in economic development; and

WHEREAS, the goals and objectives of the Seat Pleasant Advisory Board are to recommend policies for the ongoing management internal and external collaboration for the successful implementation of the Smart City technology, develop the strategic plan, establish metrics for evaluating the implementation of new Smart City Technology, applications that will improve operational efficiency, save the city resources and improve the citizen’s experience; and

WHEREAS, the Mayor will appoint with approval from the City Council seven (7) people to serve on the Seat Pleasant Smart City Advisory Board. The term shall be two years with selection of Chair and Vice Chair among the appointed members. The members will consist of two (2) representatives from the City Departments, four (4) citizens and one (1) representative from the Business community; and

WHEREAS, the duties of the Seat Pleasant Advisory Board will be meeting at least once a month to discuss, propose and plan suggestions for the Mayor and City Council of Seat Pleasant regarding Smart City solutions.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the City Council will support the Seat Pleasant Advisory Board.

AND BE IT FURTHER ENACTED AND RESOLVED that this Resolution be and is hereby adopted this 5th Day of May 2025 and shall take effect immediately upon its adoption.
