AN EMERGENCY ORDINANCE concerning.

AMENDMENT OF THE
FISCAL YEAR 2025-2026 BUDGET
FOR THE CITY OF SEAT PLEASANT, MARYLAND

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2025-2026 Budget of the City of Seat Pleasant, as enacted by Ordinance O-25-13, adopted on May 12, 2025, shall be amended for the purpose of Special Election to fill the vacant Ward II Council seat, as follows:

SECTION 2. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL

THAT an emergency exists that affects life, health, property, or the public peace requiring immediate action. The emergency is that the delay that would be occasioned by proceeding with this Ordinance as a regular ordinance effective in twenty (20) days after approval by the Mayor or approval of the City Council over the veto of the Mayor would prevent the City of Seat Pleasant from conducting the Special Election to fill the vacant council seat for Ward II within the required timeline of Seventy-Five Days.


