Election Law §10-202

No person shall be certified or act as an election judge or poll worker who is not a registered voter and resident of Prince George's County in which he or she serves, or within the City of Seat Pleasant, who holds an elective public office, or who is a candidate for public office to be voted for by the voters in Seat Pleasant.
