**AMENDMENT OF THE
FISCAL YEAR 2016-2017 BUDGET
FOR THE CITY OF SEAT PLEASANT, MARYLAND**

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2016-2017 Budget of the City of Seat Pleasant, as enacted by Ordinance O-16-08, adopted on May 16, 2016, shall be amended for Income Tax Revenue, Smart Cities Contractual Services, Housing Rehabilitation Revolving Fund and training for the Public Engagement and Finance Departments as follows:
