AN ORDINANCE concerning

FOR reenacting, without amendments comprehensive regulations relating to the Small Wireless Facilities Infrastructure on public and private property in the City of Seat Pleasant as enacted on January 7, 2019, by Emergency Ordinance No. 19-03; providing that the provisions of this Ordinance are severable; and generally relating to the comprehensive regulation of the Small Wireless Facilities in the City of Seat Pleasant.

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that Chapter 70, Small Wireless Facility, of the Code of the City of Seat Pleasant (1994, as amended), consisting of Sections 70-1 through 70-9, inclusive, as enacted on January 7, 2019, by Emergency Ordinance No 19-03 is hereby reenacted in its entirety, without amendments.

SECTION 2. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that if any provision of this Ordinance, or the application thereof to any person or Ordinance O-19-09 Small Cell Facilities
March 11, 2019

circumstance is held invalid for any reason, such invalidity shall not affect the other provisions or any other application of this Ordinance which can be given effect without the invalid provisions or application, and to this end, all the provisions of this Ordinance are hereby declared to be severable.

SECTION 3. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that, having been approved by the affirmative vote of at least five (5) members of the City Council, the City Clerk shall certify to the adoption of this Emergency Ordinance, and cause the same to be published as required by law; and that this Ordinance shall become effective upon adoption, subject to veto by the Mayor or passage by the Council after the veto by the Mayor.


