AN ORDINANCE concerning

EARLY VOTING

FOR the purpose of amending the number of days of Early Voting in municipal elections in the City of Seat Pleasant.

BY Amending
Chapter 43, Voting
Article III, Early Voting
Section 43-3 C 1
Code of the City of Seat Pleasant (1994 Edition, as amended)

WHEREAS, pursuant to Md. Code Ann., Local Gov't § 5-202(1) and § C-501(a) of the Charter of the City of Seat Pleasant (the "Charter"), the Council of the City of Seat Pleasant (the "City Council") has the power to pass all ordinances not contrary to the Constitution and laws of Maryland or the Charter as it may deem necessary for the good government of the City; and

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that Section 43-3 C 1. of the Code of the City of Seat Pleasant (1994 Edition, as amended), Chapter 43, Voting, Article III, Early Voting, is hereby amended, as follows:

Chapter 43 - VOTING

§ 43-3 GENERAL PROVISIONS.

C. VOTING BY EARLY VOTING IN MUNICIPAL ELECTIONS SHALL BE AS FOLLOWS:

(1) EARLY VOTING ((WILL)) SHALL BE ((BEGIN)) FROM TWO (2) TO SEVEN (7) DAYS ((ON)) PRIOR TO THE FIRST TUESDAY PRIOR TO THE ELECTION AND END ON THE FIRST MONDAY PRIOR TO THE ELECTION ON THE FOLLOWING SCHEDULE: FIRST TUESDAY, WEDNESDAY, THURSDAY AND FRIDAY (9:00A.M. TO 5:00P.M.), FIRST SATURDAY (9:00A.M. TO 1:00P.M.) SUNDAY (11:00A.M. TO 3:00P.M.) AND THE FIRST MONDAY (9:00A.M. TO 5:00P.M.) IN THE POLLING LOCATION DESIGNATED BY THE BOARD OF SUPERVISORS OF ELECTION.




