**AMENDMENT OF THE
FISCAL YEAR 2020-2021 BUDGET

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2020-2021 Budget of the City of Seat Pleasant, as enacted by Ordinance O-20-20, adopted on June 8, 2020, shall be amended for the Hiring and Retention of Police Officers through the Governor's Office Crime Control and Prevention for the Police Department.


