AN ORDINANCE concerning

**AMENDMENT OF THE
FISCAL YEAR 2012-2013 BUDGET
FOR THE CITY OF SEAT PLEASANT, MARYLAND**

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2012-2013 Budget of the City of Seat Pleasant, as enacted by Ordinance O-12-18, adopted on May 30, 2012, shall be amended as follows:

SECTION 2. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the vehicle purchase contracts awarded pursuant to Resolution No. R-12-17 (one 2012 Dodge Charger Police Car in the amount of \$22,749.00 and one law enforcement vehicle equipment package in the amount of \$10,586.00) are intended for use by the Chief of Police, instead of Code Enforcement officers, and

Resolution No. R-12-17 is hereby amended to reflect such change in use of the vehicle and vehicle equipment package approved for purchase pursuant to said Resolution.

SECTION 3. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that Budget Amendment Ordinance No. O-12-17 is hereby amended for consistency with amended Resolution No. R-12-17, as follows (no change in amounts, only in line item designation):




SECTION 4. AND BE IT FURTHER ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that, having been approved by the affirmative vote of at least a majority of the total elected membership of the Council shall be necessary for adoption, the City Clerk shall certify to the adoption of this Ordinance, and cause the same to be published as required by law; and that this Ordinance shall become effective immediately following approval by the Mayor or passage by the Council after the veto by the Mayor.


