**A RESOLUTION to**

**APPOINT AN ACTING CITY ADMINISTRATOR (CHIEF ADMINISTRATIVE OFFICER) FOR THE CITY OF SEAT PLEASANT AND TERMINATE CITY ADMINISTRATOR DUTIES AND RESPONSIBILITIES GRANTED TO THE MAYOR**

**FOR** the purpose of appointing an acting City Administrator (Chief Administrative Officer) for the City of Seat Pleasant; providing for the effective date and duration of the appointment; providing for compensation to the person so appointed; terminating certain duties and responsibilities granted to the Mayor; and generally relating to the appointment of an acting City Administrator (Chief Administrative Officer).

**WHEREAS**, the City Council removed the City Administrator on October 8, 2008; and

**WHEREAS**, on October 13, 2008, by Resolution 09-02 adopted in accordance with Section C-701(f) of the Charter, the City Council designated Mayor Eugene W. Grant to temporarily perform the duties and responsibilities of City Administrator (Chief Administrative Officer) until such time as a new City Administrator (Chief Administrative Officer) is appointed by majority vote of the City Council, until this designation is modified or rescinded by further Resolution of the City Council, or until 60 days from the effective date of that Resolution, whichever occurs first; and

**WHEREAS**, the City Council will not have concluded its search and appointed a new permanent City Administrator (Chief Administrative Officer) prior to the expiration of 60 days from October 13, 2008, and desires to terminate the designation of Mayor Eugene W. Grant to temporarily perform the duties and responsibilities of City Administrator (Chief Administrative Officer) and to appoint an acting City Administrator as authorized by Section C-701(f) of the Charter.

**SECTION I. NOW THEREFORE BE IT RESOLVED** by the Seat Pleasant City Council that it hereby appoints the following person to perform the duties and fulfill the responsibilities of the City Administrator (Chief Administrative Officer), as acting City Administrator (Chief Administrative Officer), as follows:

- a. The person so appointed is I. Alexander Rodriguez.
- b. The appointment shall be effective at 9:00 a.m. on Monday, December 15, 2008.
- c. The appointment shall continue until the first of the following to occur:
  1. The City Council appoints a new City Administrator (Chief Administrative Officer) and that person is selected and assumes the duties of that position;
  2. The City Council terminates the appointment of the acting City Administrator (Chief Administrative Officer) appointed by this Resolution; or
  3. The acting City Administrator (Chief Administrative Officer) appointed by this Resolution resigns that position.
- d. The acting City Administrator (Chief Administrative Officer) appointed by this Resolution shall receive compensation, payable bi-weekly in accordance with the City's normal payroll schedule, at the rate provided for the position of City Administrator (Chief Administrative Officer) in the City's annual budget, commencing December 15, 2008 and continuing for as long as the person serves as acting City Administrator (Chief Administrative Officer).

**SECTION II. AND BE IT FURTHER RESOLVED** that the designation of Mayor Eugene W. Grant pursuant to Resolution 09-02 to perform the duties and responsibilities of City Administrator (Chief Administrative Officer) is rescinded as of 9:00 a.m. on Tuesday, December 9, 2008.


**SECTION III. AND BE IT FURTHER RESOLVED** that this Resolution shall take effect immediately.
