**A RESOLUTION to**

**AMEND RESOLUTION NO. 09-18 AND RESOLUTION NO. R-09-20 TO DELAY THE EFFECTIVE DATE OF THE APPOINTMENT OF A CITY ADMINISTRATOR (CHIEF ADMINISTRATIVE OFFICER) FOR THE CITY OF SEAT PLEASANT**

**FOR** the purpose of delaying the effective date of the appointment of a City Administrator (Chief Administrative Officer) for the City of Seat Pleasant and for the termination of the appointment of the Acting City Administrator (Chief Administrative Officer); and generally relating to the appointment of a City Administrator (Chief Administrative Officer).

**WHEREAS**, pursuant to Resolution No. R-09-18, adopted on April 29, 2009, the City Council appointed Deron W. King as City Administrator (Chief Administrative Officer) for the City of Seat Pleasant; and

**WHEREAS**, Resolution No. 09-18 provided that the effective date of the appointment of Mr. King, and the appointment of Robert L. Ashton as Acting City Administrator (Chief Administrative Officer), would terminate on May 11, 2009; and

**WHEREAS**, Resolution No. 09-20 extended the effective date of the appointment of Mr. King, and the appointment of Robert L. Ashton as Acting City Administrator (Chief Administrative Officer), until May 26, 2009; and

**WHEREAS**, the City Council desires to further delay the effective date of Mr. King's appointment as City Administrator (Chief Administrative Officer) and the date of termination of Mr. Ashton's appointment as the Acting City Administrator (Chief Administrative Officer).

**SECTION I. NOW THEREFORE BE IT RESOLVED** by the Seat Pleasant City Council that it hereby amends SECTION I.b. of Resolution No. 09-18, as amended by Resolution No. 09-20, to read as follows:


- b. The appointment shall be effective on such date and at such time as may be determined by the City Council, subject to acceptance of the appointment by the City Administrator (Chief Administrative Officer). Subject to acceptance of the appointment, the City Administrator (Chief Administrative Officer) shall assume the duties and responsibilities of the position and commence work on such date and at such time as shall be mutually agreed by the City Council and the City Administrator (Chief Administrative Officer).

**SECTION II. AND BE IT FURTHER RESOLVED** by the Seat Pleasant City Council that it hereby amends SECTION II of Resolution No. 09-18, and amended by Resolution No. 09-20, to read as follows:


**SECTION II. AND BE IT FURTHER RESOLVED** that the appointment of Robert L.
