**A RESOLUTION concerning**

Recovery Act: Edward Byrne Memorial Justice Assistance Grant (JAC) Formula Program: Local Solicitation

**FOR** the purpose of approving the application by the Seat Pleasant Police Department (“SPPD”), a Department of City of Seat Pleasant for funding through the Edward Byrne Memorial Justice Assistance Grant

**WHEREAS**, the American Recovery and Reinvestment Act of 2009 (Public Law 111-5), which was signed into law by President Obama on February 17, 2009; and

**WHEREAS**, The City of Seat Pleasant is applying to the Edward Byrne Memorial Justice Assistance grant (JAG) Formula Program, for the “Local Solicitation,” to establish the Speed Camera Citation Program “Speed Camera Citation.” program in Seat Pleasant; and

**WHEREAS**, the project promotes the safe and consistent enforcement in Seat Pleasant; and

**WHEREAS**, the City believes that the use of speed cameras in school zones in the City will help prevent speeding and will benefit the public’s health, safety, and welfare.

**NOW, THEREFORE,**

**SECTION I: BE IT RESOLVED BY THE SEAT PLEASANT CITY COUNCIL** that the City Council hereby approves the application of submitted to the United States Department of Justice, Office of Justice Programs for participation in the Bureau of Justice Assistance Program in the amount of \$3,361, 930 under the Recovery Act, awarded to the State of Maryland, and.

**SECTION II. BE IT FURTHER RESOLVED THAT**, the Mayor be, and is hereby requested to endorse this Resolution, thereby indicating his approval thereof; and,




