WHEREAS, the City of Seat Pleasant Mayor and City Council recognizes that there is a

WHEREAS, the Area is located within a priority funding area under Section 5-7B-02 of the Smart Growth Act and the Project will conform to the local zoning code; and

WHEREAS, the applicable law and regulations require approval of the Area designation, the Project and Project Financing by the City of Seat Pleasant Mayor and City Council;

NOW, THEREFORE BE IT RESOLVED THAT, the City Council of the City of Seat Pleasant hereby endorses the designation of the Community Legacy Area and the Project in
