**Approval of Service Agreement for School Zone Speed Monitoring System**


**FOR** the purpose of approving a certain Service Agreement between Optotraffic, a Division of Sigma Space Corporation, and The City of Seat Pleasant for Optotraffic to provide school zone speed monitoring system services to the City.

**EXPLANATORY STATEMENT:** The City of Seat Pleasant intends to implement a system of motor vehicle speed enforcement in certain school zones in the City using a portable equipment speed monitoring system. The City has determined that the speed monitoring equipment and related administrative services offered by Optotraffic, a Division of Sigma Space Corporation, will best serve the City's needs. Optotraffic has agreed to provide the equipment and administrative services to the City under the terms and conditions set forth in the Service Agreement attached to this Resolution and incorporated herein by reference. The City Council has determined that this Service Agreement is in the best interests of the City. Now, therefore,


**SECTION I. BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SEAT PLEASANT,** that the City Council hereby approves the Service Agreement between Optotraffic, a Division of Sigma Space Corporation, and The City of Seat Pleasant in substantially the form of Service Agreement attached to this Resolution and authorizes the City Administrator to execute the Agreement on behalf of the City, subject to any such non-substantive revisions to the Service Agreement as the City Attorney and City Administrator may deem appropriate.

**SECTION II. BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF SEAT PLEASANT,** that this Resolution shall take effect upon the adoption and taking effect of Ordinance O-11-02, but if Ordinance O-11-02 is not adopted by the City Council, or if that Ordinance does not take effect after its adoption by the City Council, this Resolution shall be null and void without further action by the City Council.
