A RESOLUTION to

RESCIND THE APPOINTMENT OF A CITY ADMINISTRATOR (CHIEF ADMINISTRATIVE OFFICER) FOR THE CITY OF SEAT PLEASANT AND CONTINUE APPOINTMENT OF ACTING CITY ADMINISTRATOR

FOR the purpose of rescinding the appointment of Deron King as City Administrator (Chief Administrative Officer) for the City of Seat Pleasant and continuing the appointment of Robert L. Ashton as Acting City Administrator (Chief Administrative Officer).

WHEREAS, pursuant to Resolution No. R-09-18, adopted on April 29, 2009, the City Council appointed Deron W. King as City Administrator (Chief Administrative Officer) for the City of Seat Pleasant, to be effective on May 11, 2009; and

WHEREAS, Resolution No. 09-18 provided that the effective date of the appointment of Mr. King, would be and the appointment of Robert L. Ashton as Acting City Administrator (Chief Administrative Officer) would terminate on, May 11, 2009; and

WHEREAS, Resolution No. 09-20, adopted on May 11, 2009 extended the effective date of the appointment of Mr. King, and the appointment of Robert L. Ashton as Acting City Administrator (Chief Administrative Officer), until May 26, 2009; and

WHEREAS, Resolution No. 09-21, adopted on May 29, 2009 further delayed the effective date of Mr. King's appointment as City Administrator (Chief Administrative Officer) until a date determined by the City Council; and

WHEREAS, Resolution No. 09-21 provided that the appointment of Robert L. Ashton to serve as Acting City Administrator (Chief Administrative Officer) would be terminated without further action of the City Council on such date and at such time as the new City Administrator (Chief Administrative Officer) assumes the duties and responsibilities of that position; and

WHEREAS, the City Council and Mr. King agreed that the effective date of his appointment would be August 3, 2009; and

WHEREAS, Mr. King requested, and the City Council agreed, that the effective date of his appointment, and his first day of employment, be extended until August 17, 2009; and

WHEREAS, Mr. King did not assume the duties and responsibilities of City Administrator (Chief Administrative Officer) and commence work on August 17, 2009 as agreed; and

WHEREAS, the City Council has determined that the rescission of Mr. King's appointment as City Administrator (Chief Administrative Officer) and the continuation of the appointment of Robert L. Ashton as Acting City Administrator (Chief Administrative Officer) would best serve the interests of the City.

SECTION I. NOW, THEREFORE, BE IT RESOLVED by the Seat Pleasant City Council that it hereby rescinds the appointment of Deron King as City Administrator (Chief Administrative Officer) for the City of Seat Pleasant.

SECTION II. AND BE IT FURTHER RESOLVED that the appointment of Robert L. Ashton as Acting City Administrator (Chief Administrative Officer) is continued until the first of the following to occur:

1. The City Council appoints a new City Administrator (Chief Administrative Officer) and that person is selected and assumes the duties of that position;

2. The City Council terminates the appointment of the acting City Administrator (Chief Administrative Officer) continued by this Resolution; or

3. The acting City Administrator (Chief Administrative Officer) continued by this Resolution resigns that position.

SECTION III. AND BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
