A RESOLUTION concerning

THE APPROVAL OF AN APPLICATION FOR, AND RECEIPT OF, FINANCING FOR THE SMART/INNOVATION CITY PROJECT FROM THE UNITED STATES DEPARTMENT OF AGRICULTURE.

WHEREAS, the City Council of the City of Seat Pleasant (the “City Council”) and the Mayor of the City of Seat Pleasant (the “Mayor”) propose to undertake the project described above (the “Project”); and

WHEREAS, the City of Seat Pleasant has applied to the United States Department of Agriculture (“USDA”) for funding of the Project in the amount of \$4,100,000.00 under USDA’s Public Safety Program; and

WHEREAS, the City Council and the Mayor approve the Project for the expansion of the City Hall and Public Works building to include a state-of-the-art Seat Pleasant Information Technology Center (“SPITC”).

NOW, THEREFORE BE IT RESOLVED THAT the City Council hereby endorses the Project and hereby approves the City’s application for Project financing in the form of a grant, loan, or other financial vehicle in the approximate amount of \$4,100,000.00; and

BE IT FURTHER RESOLVED THAT the Mayor, as the chief elected executive official for the City, be and he is hereby requested to endorse his signature on this Resolution, thereby indicating his approval thereof; and

BE IT FURTHER RESOLVED THAT the Mayor and the City Council are hereby authorized to execute any and all documents and take any and all action necessary to carry out the intent of this Resolution; and


BE IT FURTHER RESOLVED THAT, upon adoption, copies of this Resolution shall be sent to the USDA; and




