WHEREAS, the city wishes to formally define the standards acceptable by the city for incoming businesses and the potential improvements to existing businesses; and

WHEREAS the Economic Development Department wants to submit an application to the Prince George's County Planning Department, Planning Assistance to Municipalities and Communities Program (PAMC), for the creation of a Seat Pleasant Business portfolio for potential business investors, and

WHEREAS, PAMC provides technical assistance to municipalities and communities in Prince George's County that need assistance with any initiative that assist with redevelopment, revitalization and community or area plan implementations, and



SECTION III. AND BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.






