**FOR** the purpose of approving the purchase of the properties in accordance to Chapter 115-Housing Trust and Revolving Loan Fund for the City of Seat Pleasant.

**EXPLANATORY STATEMENT:** The City Council approved the Ordinance O-17-13 Seat Pleasant Housing Trust Fund and Revolving Loan Fund as a sound public policy that will provide needed resources to support affordable housing development, preservation and neighborhood revitalization and strengthen the City's economic development goals. The City Council has determined that this Service Agreement is in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SEAT PLEASANT. SECTION I.** that the City Council hereby approves the purchase of the property located at 710 71<sup>st</sup> Ave., Seat Pleasant Dr., Seat Pleasant, MD for \$88,489.29.






