**WHEREAS**, the City is responsible for pursuing the adopted Seat Pleasant Strategic Outcome to Expand health awareness and cultural and leisure activities; and,

**WHEREAS**, one of the components of this strategic outcome is to promote and educate community and staff on alternative eating and physical activity through Ward meetings and community events; and

**WHEREAS**, SAFE0 is an Out-of-School-Time Community Service Learning program that engages Prince George's County middle and high school student volunteers to tackle the issue of childhood obesity and their families by conducting survey-based mapping activities in low-income and under-served districts in the County who may lack access to healthy food and fitness alternatives, collect data, and,

**WHEREAS**, these surveys would be conducted by students from Central High School as a meaningful project towards their service-learning graduation requirements; and,

**WHEREAS**, the students will conduct fact-finding investigations, collect data, catalog and use the mapped data to draw conclusions about increasing health indicators through behavioral changes. identifying healthy lifestyle deficits in community services and retail opportunities; and,

**WHEREAS**, the Prince George's County Planning Department, Planning Assistance to Municipalities and Communities Program (PAMC) program representatives highly recommended Seat Pleasant as a great community for conducting these surveys; and,

**WHEREAS**, PAMC provides technical assistance to municipalities and communities in Prince George's County that need assistance with any initiative that assist with redevelopment, revitalization and community or area plan implementations; and

**WHEREAS**, PAMC will be providing SAFE0 with technical assistance in the development of the **Prince George's County Youth Healthy Lifestyles Community Mapping Program**; and,

**WHEREAS**, this data will become part of Seat Pleasant's efforts to further enlightened its citizenry on healthy lifestyles through information provided on the My Seat Pleasant App, the City website and the City newsletter

**NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF SEAT PLEASANT**, hereby supports and approves the submission of an application to the PAMC program for the development of the **Prince George's County Youth Healthy Lifestyles Community Mapping Program** and authorizes the Chief Operating Officer approve the final submission subject to any non-substantive revisions to the application by the City Attorney and Chief Operating Officer which may be deemed appropriate.


**BE IT FURTHER RESOLVED, THAT THE APPLICATION IS ATTACHED HERETO AS A PART OF THIS RESOLUTION.**






