FISCAL YEAR 2011-2012 BUDGET

SECTION 1. BE IT ORDAINED BY THE SEAT PLEASANT CITY COUNCIL that the 2011-2012 Budget of the City of Seat Pleasant, as enacted by Ordinance O-11-08, adopted on May 31, 2011, shall be amended as follows:




