**A RESOLUTION concerning**

**Approval and Participation in the Prince George's Intergovernmental Network  
Community Coordinating Committee**

A Resolution authorizing and endorsing the City's participation in the Prince George's Intergovernmental Network Community Coordinating Committee (I-Net) as of a certain date; approving the Bylaws of that Committee; and urging that the City's FY 2012 budget contain sufficient appropriation for the City's participation in the I-Net in FY 2012.

**WHEREAS**, the Seat Pleasant City Council recognizes that there is a significant need for the City to participate in and connect to the I-Net and desires to provide for this participation and connection.

**NOW, THEREFORE,**

**SECTION I: BE IT RESOLVED BY THE SEAT PLEASANT CITY COUNCIL** that the City Council hereby authorizes and endorses the City's participation in and connection to the I-Net effective as of July 1, 2011, and approves the I-Net Bylaws as amended through February 25, 2011 by the I-Net Committee; and

**SECTION II. BE IT FURTHER RESOLVED THAT** the City Council urges that the City's FY 2012 budget contain sufficient appropriation for the City's participation in the I-Net in FY 2012.

**SECTION III. BE IT FURTHER RESOLVED THAT** the Mayor be, and is hereby requested to endorse this Resolution, thereby indicating his approval thereof; and,
