A RESOLUTION concerning

THE APPROVAL OF AN APPLICATION FOR, AND RECEIPT OF, FINANCING FOR AN ENGINEERING AND ENVIRONMENTAL STUDY FOR A STORMWATER MANAGEMENT SYSTEM FROM THE STATE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT OR OTHER STATE DEPARTMENTS OR AGENCIES.

WHEREAS, the City Council of the City of Seat Pleasant (the "City Council") and the Mayor of the City of Seat Pleasant (the "Mayor") propose to undertake the project described above (the "Project"); and

WHEREAS, the City of Seat Pleasant has applied to the Department of Housing and Community Development (the "Department") of the State of Maryland for funding of the Project in the amount of \$25,000 under the Department's Technical Assistance Grant; and

WHEREAS, the City Council and the Mayor approve the Project for an Engineering and Environmental Study for a Stormwater Management System, as well as the application for, and receipt of, funding from the Department or through other State departments or agencies for the Project.

NOW, THEREFORE BE IT RESOLVED THAT the City Council hereby endorses the Project and hereby approves the City's application for Project financing in the form of a grant, loan, or other financial vehicle in the approximate amount of \$25,000; and

BE IT FURTHER RESOLVED THAT the Mayor of the City of Seat Pleasant, as the chief elected executive official for the City, be and he is hereby requested to endorse his signature on this Resolution, thereby indicating his approval thereof; and






